No work, at any time, can be substituted for a work that is not published by Devilish Publishing. | No cash alternative is offered. | Every 2nd month you shall receive a free brass quartet or quintet piece of our choosing. | The additional discount of 35% can be used for any other sheet music purchase. This discount extends to the whole Devilish Publishing music catalogue, including that of Black & White Editions. | The free introductory gifts will be dispatched within 28 days. Free publication(s) is of the customer’s choosing (from a set selection) within the retail price of £24.99. No cash substitute is offered. | “Success!”, the editorial publication shall be sent to the customer (by post) quarterly and shall receive all issues on pro-rata basis of the duration of the “Friends of...” term. | “term” is defined as the period of time which the “Friends of...” membership is valid. | Each renewed year shall see a continuation of the publication from the last issue so sent.
